2. The primary duty of a Coach is to be fair to each and every member of a squad at all times
3. The Coach must observe all safety rules that pertain to mounts, dismounts, cheers, chants, etc.
4. Coaches shall handle all discipline within their squad by following the demerit procedures as outlined by the FCCJC By-Laws. Area Director and parents must be notified of all demerits given as incurred.
5. Professionally taught cheerleading classes may not be mandatory. Material taught may not be performed at any FCCJC function, unless taught at the weekly FCCJC practice.
6. The Head Coach is responsible for filing an Injury Report Form with the FCCJC office as soon as possible after a Cheerleader is injured.
7. Coaches must attend the Area Director's Coaches Meetings and an appropriate coaches seminar. Failure to attend will result in rejection of this application.
8. Cheerleading Coaches are encouraged to attend the FCCJC Annual Meeting held each December.

I also understand that I am expected to have a thorough knowledge of the FCCJC Cheerleading Rulebook and that the Sportsmanship Committee will not accept "I didn't know" when considering rule infractions.

By signing below and providing my social security number and date of birth above, I authorize FCCJC to obtain information regarding myself in order to be considered for a coaching position. This includes a national criminal background check and sex offender registry. \*\*Applicants refusing to provide this information in order for the background check to be conducted will not be allowed to coach in the FCCJC program.
